Superintendent Spears presented comparative data from other lowa school districts regarding 1:1 technology. Mr. Spears does not believe the district is ready for 1:1 but has plans to implement a "grant" program that teachers can apply for if they are interested in implementing additional technology devices in their classroom. The district will set aside \$75,000 for technology which will enable the district to award ten "grants" of \$7500 for individual teachers or groups of teachers to add 30 devices to be used only in their classroom or area. Plans to distribute Requests for Proposal will help determine what type of devices the district will utilize.
