## C. Administration

- 1. Elementary School Mrs. McCrory reviewed her report, which was included in the Board Packet. Mrs. McCrory also showed the Board the large check for \$7,500 that was awarded to East Elementary from HyVee. The HyVee food stores, in honor of their 75th Anniversary, are allowing selected stores to draw from registrations at the stores, and select a student who is the winner of an IPOD. The school where the student attends also receives a check for \$7,500 to be spent by the school. The Sheldon HyVee was selected to draw a winner, and the student, Emily Johnson received the IPOD, and the school received the check for \$7,500.
- 2. Middle School Mrs. Barwick reviewed her report, which was included in the Board Packet.
- 3. High School Mr. Mueting reviewed his report, which was included in the Board Packet. Mr. Mueting also said that the Sheldon High School would be one of the 20 high schools in Iowa to participate in the Iowa High School Project.

#### 5. Superintendent

a. 7th & 8th Grade Wrestling Sharing Agreement with South O'Brien Community School District - Superintendent Spears said that there will not be any sharing of

- the 7th & 8th Grade wrestling this year. It could be worked in with the High School agreement, when it is re-evaluated.
- b. Iowa Ethics and Campaign Disclosure Board Ruling The Superintendent stated that the District had received and email from Charlie Smithson, Chairperson of the Ethics Board, stating that the District was in violation, and appreciated the self-reporting. Superintendent Spears furnished Mr. Smithson with additional information on how the violation happened. Marv Van Riesen had filed a request to discuss this issue with the Board. Marv thanked Superintendent Spears for taking responsibility for the incident. Marv said that this was not an isolated incident, and expressed his concerns about the technology of the District. He felt that the original need for technology was for the students, but felt that over the years it has gotten out of hand. Mr. Van Riesen suggested that there should be a random check on the hardware. Marv didn't receive the email, and wondered why only certain people received the email. He thinks that the policies of the District are being enforced on a double standard.
